

## PRIVACY POLICY

This Privacy Policy informs you about which personally identifiable information «Don Quixote» LLC collects within the offered services and how these data are processed and used. We are committed to safeguarding the privacy of our guests. We will treat any personal information supplied by you as confidential and will only process such information as permitted by legislation. Your data is protected from unauthorized access and leaks of various methods: electronic, technical, physical, contractual and administrative. The company "Don Quixote" undertakes the necessary technical and organizational measures that guarantee the observance of the data protection regulations both inside the company and with the central service providers.

«Don Quixote» LLC collect, store and use the following kinds of personal information:

- information that you provide to us for the purpose of subscribing to our email notifications and/or newsletters
- information that you provide to us when booking on websites, or that is generated in the course of the use of those services
- information contained in or relating to any communication that you send to us or send through our website (including the communication content and metadata associated with the communication);
- any other personal information that you choose to send to us.

Also, "Don Quixote" LLC collects data related to use, if they are necessary for providing a service or invoicing for it. Such information includes information about services rendered and invoices issued for them. As part of using its Internet pages, Don Quixote LLC collects the following non-personal data:

- IP-addresses with time instructions;  
- temporary files, local flash data;  
- statistical information such as browser type, operating system, URL from which you were redirected to our page, date, time, visited pages, visit duration, Frequency of visits. The collected data is processed anonymously and used exclusively for statistical purposes.

IP-addresses and related Internet information are kept by us for a maximum of 6 months in accordance with the statutory duty of data storage. In addition, storage may be required for data security reasons and to ensure the stability and operational reliability of our system. In some cases, the website [www.donquixote-](http://www.donquixote-)

kazan.com may also contact your IP address and relevant Internet data in order to establish and terminate the misuse of several accounts for criminal purposes.

We using your personal information for:

- for rendering services and billing for them;
- in pseudonymized and / or anonymized form with the aim of satisfying consumer requests and optimizing products;
- to fulfill legislative obligations, first of all, storage obligations.

In addition, we use data to communicate with you. This includes, first of all, the provision of assistance and support, as well as the provision of information relating to your order. If you have the consent of your side, we regularly inform you about news, promotions and events, for example, by email, phone or SMS. Your data is kept strictly confidential and is not transferred to third parties, unless you give us your explicit consent to the transfer of your data to third parties. However, in exceptional cases, "Don Quixote" LLC is obligated to transfer your data to the investigative authorities in accordance with the requirements of the law. At the same time, data transmission occurs exclusively in the framework defined by law. This site uses the Analytical web service GoogleAnalytics, offered by GoogleInc. ("Google"). GoogleAnalytics uses the so-called "Cookies", i.e. Text files stored on your computer and allowing you to analyze your behavior on the site. Information about your behavior on the site, obtained with the help of cookies, is usually transferred to a Google server in the US and stored there. If anonymization of IP addresses is activated on this site, Google previously deletes the end of your IP address in the territory of the countries of the European Union or other states party to the agreement on the European Economic Area. Only in exceptional cases, the full IP-address is transferred to one of the Google servers in the US and is reduced there. At the request of the provider of this site, Google will use this information to analyze your behavior on the site, compile reports on the activity on the site, and to provide the site provider with other services related to the use of the site and the Internet. The connection between the IP address transmitted via GoolgeAnalytics and other Google data is not tracked. You can prevent the storage of cookies by using the appropriate settings in your browser. Please note, however, that in this case, you may not be able to use all the functions of this site to the fullest. through anonymous collection and processing of data about your behavior on the site and forecasting of interests. For this purpose, third-party services on our behalf installed on your computer Cookies, collecting user data. We are talking about data acquired during your stay in the pages of this site and clicking on the promotional materials. Thus, we can analyze your use of the online advertising and display promotional materials for you, that might be interesting for you and meet your preferences ("The targeting internet advertising"). In this case, no personal data (for example, name, address, e-mail) is not saved. IP-addresses are anonymized, so that any identification of a person is excluded. In addition, we allow other third-party companies, for example, media agencies, to install cookies to analyze the use of online advertising and display on our site special advertising that interests you exactly and meets your preferences.
